





Propositions:


- Clarity over policy objectives, instruments and timescales.
- A willingness to both produce and cope with more honest policy prediction.
- Increased policy literacy and understanding of policy instruments by professionals and their representative organisations.
- A culture and a collectively agreed means of reporting back on policy and project outcomes by all parties from government to companies and individual professionals. A regular reporting system on policy effectiveness.
- An understanding that policy is a live activity requiring continuous monitoring and course correction as a precondition of implementation.

Measures to make policy more effective:

- Consciously learning lessons from the past
- Building in resilience capable of accommodating change to both political circumstances and the external environment
- Understanding the probability of and extent of success
- Open and inclusive ideas generation
- Transparent and accessible policy appraisal
- Policy trialling and testing as part of the design process
- Policy championing throughout the delivery stages
- The collection and evaluation of data on both process and outcomes for feeding back into future policy-making and assessment.
